

**GOLF SE  
PENNANT CONDITIONS 2018**

**REGISTRATION:** All Clubs must register teams by no later than the January 6<sup>th</sup> 2018 - number of teams with players' names and GA handicaps (not reserves) to the GOLF SE Ladies match committee.

**DIVISIONS:** Will be decided by the GOLF SE Ladies Match committee depending on the number of teams in each grade.  
There shall be five (5) players per team, with no limit to the number of teams entered by a club.

**FORMAT:** *All pennant matches will be handicap match play. Players will use their GA Handicap (as per Golf Link), to determine their Slope Adjusted Daily Handicap. All clubs must display Slope Rating Sheets for calculation before the start of play.*  
Teams of five (5) are to be entered. Handicaps will be averaged by the committee and teams allocated to the appropriate Division. A maximum handicap for each Division will be determined.

**A Grade.** Four out of five players must be within the handicap range. A higher handicap player may be used but must play off the adjusted Daily Handicap based on the **maximum GA handicap (22)**.

**All other Divisions** – As with A Grade, a higher handicap player may be used but must play off the adjusted Daily Handicap based on the **maximum GA handicap** for that Division.

**Divisions for 2016**

<b>A Grade</b>	<b>22 GA</b>
<b>Div 1</b>	<b>30 GA</b>
<b>Div 2</b>	<b>40 GA</b>
<b>Div 3</b>	<b>45 GA</b>

**CONDITIONS:**

1. Players' Golf Link card must be carried at all times and produced on request.
2. Once a player has **played twice in any team** the player is then tied to that team, unless required to move to a higher division.
3. **PLAYERS MUST BE ON THE TEE 5 MINUTES BEFORE THE SCHEDULED TIME:** Penalty – loss of first hole.
4. Teams playing in finals shall comprise of only players who have played in at least one (1) match prior to the finals.
5. If a club is unable to field a full team the team captain must notify the opposing club of the number of players available. The bottom place or places are automatically forfeited. Players receiving a forfeit are deemed to have played and must be named on the result sheet, in handicap order.
6. In the case of a team receiving a forfeit en mass, the team named by the receiving Club is deemed to have played. The team receiving the forfeit must forward names of the **five players on a result sheet to:**

7. A Grade matches play to a result. All other divisions finish on the 18th hole.
8. Mobile phones must be turned off when on the golf course and may only be used in an emergency. (Refer section 1 Etiquette; Behavior on the course – Consideration for Other Players and Rule 33.7 in the Rules of Golf and the Rules of Amateur Status book).
9. Ride-on buggies are allowed subject to club regulations.

**PLAYERS:**

**Players must play in order of lowest handicap to highest.** Penalty – disqualification  
All players play off the first (1<sup>st</sup>) tee.  
A player who belongs to two clubs within the District may only play for her nominated home club.  
A player whose nominated home club has not entered a Pennant team may play for another club within in the District. A Country Member may play for a club they hold a country membership with.

**DUTIES:**

Host club is to provide morning tea. **COST \$5 PER TEAM**  
Player is to supply her own lunch.  
Team Captains to start matches and toss for honour.  
The score sheet is to be signed by both captains, with the winning team's captain to forward the sheet to **Sandie Elsdén, Pennants Coordinator** on the same day of play.  
**If the results are not received by Wednesday, it will be considered a draw.**

**POINTS/HOLES:**

All teams shall score 2 points for a win or forfeit and 1 point for a halved match. In the event of a tie the **GOLF SA Points System** will be used to calculate holes won by each individual player and recorded on the score sheet to assist with potential further count back deliberations. The finishing hole of play MUST be recorded on the scoring sheet for verification of score.

**DISPUTES:**

The Captain of a team may protest by telephone if they feel the opposing team or players have made a breach of the regulations.  
**ALL** protests must be confirmed in writing within 48 hours to the **Sandie Elsdén, Pennants Coordinator** and shall be settled by the GOLF SE Ladies Match Committee. GOLF SE Ladies Match Committee reserves the right to disqualify any team or player it deems in breach of the regulations regardless of a protest being lodged.

**FINALS:**

In the event of a final **ALL** MATCHES must be played to a result.

**SUNSMART & HEAT POLICY:**

As per Golf SA Conditions except in the consideration of FORECAST TEMPERATURES AT NARACOORTE (ON THE BUREAU OF METEOROLOGY WEBSITE) THE NIGHT BEFORE BEING 34 DEGREES OR GREATER, ALL SCHEDULED MATCHES AT ALL CLUBS ARE AUTOMATICALLY CANCELLED. Pennant Captains will have the responsibility to notify their teams and all matches will be deemed a draw.

**WET WEATHER POLICY**

Both captains must agree to deem the course unplayable - games will be drawn with 1 point allocated to each team.  
In the case of captains not in agreement then the game shall be continued.

**The right to alter or add to the existing pennant conditions remains with the GOLF SE Ladies Match Committee.**
